CENTRELINK AND VETERAN'S AFFAIRS PENSIONS

Pensioner Couple (on death of one)

Generally a pensioner whose pensioner spouse dies may receive a Bereavement Payment. If you were both getting a pension you will get a lump sum Bereavement Payment. The lump sum is calculated by multiplying the difference between the amount you both were receiving and the single rate you will be paid as a single pensioner by a factor of seven.

Single Pensioner

The estate may be eligible to a Bereavement Payment. If a deceased person was receiving a Veteran's Affairs or Centrelink pension or other benefits, the appropriate department should be notified of the death within 14 days.

Veterans

Veterans whose deaths are accepted as being caused by war service and those on TPI pensions may be eligible for additional assistance.
